#### **OPENING REMARKS**

1. Commander John Lee introduced two guest speakers; Judy Clay from Willamette Valley Quilts of Valor (QoV), and Brian representing the School Board who was here to talk about the proposed school bond issue.

Judy spoke first and explained to us that, along with many other veterans in the Willamette Valley, her organization has honored as many as 150 veterans with quilts at the Veterans Home in Lebanon. She informed the group that QoV will be at the home again on the afternoon of November 7<sup>th</sup> and encouraged us all to attend.

Judy brought with her a colorful new quilt that was presented to Turner Whitfield. As with all the quilts made by this talented group of ladies, this quilt had Turner's name, his branch of service and the dates he served stitched into one of the corners. Turner was surprised and happy to find out that the quilt was actually made by his wife.

2. Next Brian was given the opportunity to speak to the membership about the school bond issue that we will be voting on again in November. He began by telling us that the School Board believes that this bond was voted down last year because of the cost and because voters were not provided with enough information. He spent the next few minutes telling us about the plans for the new building and what the voter approved bond will fund and then concluded by telling us that this information and much more can be found on their website: www.clsbond.org.

Brian finished up by answering questions from the membership. He then thanked the group for the opportunity to come and talk to us.

#### **BUSINESS**

- 1. As required, Commander John Lee read for the second time the revised resolutions that amend our Post By-Laws and Constitution. As each resolution was read, a motion was made and the membership voted on it. The results:
  - Article V, Sec. 1 of the Post By–Laws, Finances and Dues Kneil Stucky moved that we accept, Norm Simms seconded. A vote by the membership carried the motion.
  - Article VI, Sec. 2 of the Post Constitution, Finances and Dues Rick Dominguez moved that we accept, Kneil Stucky seconded. A vote by the membership carried the motion.
  - Article VI, Sec. 4 of the Post Constitution, Finances and Dues Rick Dominguez moved that we accept, Mike McDaniel seconded. A vote by the membership carried the motion.
- 2. The Finance Report was distributed and Norm Simms explained that:
  - Our Post made \$187 on the Bazaar. He mentioned that the "seed" money used to make change was also deposited back into our account.
  - A run was made to Costco and supplies for the building were purchased.
  - Our Building Fund Saving Account remains over \$4,000.

- The money in the Restricted Funds column for Street Flags should be transferred to our checking account.
- The \$1,250 donated toward our mortgage was very much appreciated.
   Norm explained that if all goes well, we will have our loan paid off in about 8 years.

Brad Boles made a motion to accept the report as reviewed and Mike McDaniel seconded. A vote by the membership carried the motion.

3. The minutes for last month's meeting were distributed for review and, since there were no questions or comments, a motion was made by Mike McDaniel to accept the minutes as presented. Carl Frank second to the motion and a vote by the membership carried the motion.

- Post Revitalization Saturday, October 14, 12N to 4pm we will be meeting at the Legion. Letters were mailed out earlier this week to the 150 members that have not yet paid their 2018 dues. On Saturday, we will also be calling to remind them.

- Veterans Day Parade November 11<sup>th</sup>, Albany. Same discussion as last month about military jeep pulling our float.
   Someone suggested that we may want to include our wooden military figures on the float if it is not raining. Turner Whitfield added that if we cannot find a military jeep, he may know someone who has one. Rick Dominguez volunteered to help build props for the float.
- Turkey Dinner Before American Legion Meeting Tuesday, November 14<sup>th</sup>, 6pm here at the Legion. Kneil and Cindy Stucky will be providing a turkey dinner before our meetings.
