OPENING REMARKS

Since there were no visitors to introduce, nor any other comments, Commander John Lee moved directly into the business at hand.

BUSINESS

1. The Finance Report was distributed. Finance Officer Norm Simms explained that our post received two donations recently totaling \$1,200 and that the money was applied to the principle of our building loan. By doing this, we have been able to reduce our mortgage by eight years. He asked if there were any questions about the report and there were none. A motion was made by First Vice Commander Brad Boles to accept the report as reviewed and was seconded by Comrade Marty Cross. A vote by the membership carried the motion.

- 2. The minutes for last month's meeting were distributed earlier for review and, since there were no questions or comments, a motion was made by Brad Boles to accept the minutes. A second to the motion was offered and a vote by the membership carried the motion.
- 3. John Lee informed the membership that he has recently reviewed our Post By-Laws and our Constitution and found it necessary to update them. He told the group that he talked to officers at the District and received good advice on how to make these changes. He explained that the first update was to change the language in our By-Laws as it relates to our post dues. He then read aloud Resolution No. 2017-1 (attached) that was developed to make this By-Law change. After reading the resolution, he asked if there were any questions. There were none.

John then explained that our Post Constitution needed to be updated for the same reason and then read aloud Resolution No. 2017-2 (attached) that makes this change to the Post Constitution. He asked if there were any questions and Comrade Brad Wright asked for clarification on why the two resolutions. John replied that the different resolutions were written because Resolution No. 2017-1 was to change the *Post By-Laws* and Resolution No. 2017-2 was to change the *Post Constitution*.

John explained that the last resolution, Resolution No. 2017-3 (attached), was written to update our Post Constitution on how we are currently handling our checks and our debit card. Whenever a check is written by the Post Finance Officer, it must be counter signed by another officer on the approval list. When the Finance Officer uses the debit card, the expenditure must be approved by the Post Commander. Sergeant-at-Arms Mike McDaniel asked if this approval is done before or after the expenditure and Norm replied that it is done before.

John Lee told the group that he will be emailing copies of these resolutions out to our membership and will read them again at our October meeting. Afterwards, we will vote on them.

- 4. Norm Simms has verified with our insurance company that all officers that handle post funds are indeed Bonded.
- 5. John Lee informed the group that we will be moving forward with the scraping, sanding, and repainting of wooden surfaces on the outside front of our building. A decision was made that the color will be "American Legion" blue and gold. We estimate three gallons of paint should be sufficient and that most of the wood can be patched with putty where needed. We will be getting with members and asking for volunteers to get this done in the next few weeks if possible.

Carl Frank asked how will members be notified when it is time to do the work and John Lee replied by email and phone call.

Norm Simms asked if anyone knew of anyone who may have scaffolding and Second Vice Commander Rick Dominguez replied that our Chaplin Jim Weger does. Norm told the group that he also plans to elevate the flag pole so the flag can be raise higher over the building.
